Circular On : All Assam Inter-College/University Debating Competition

The Institute of Tai Studies and Research is organising a debating competition on the issue to be moved by the Treasury Bench: "In the Interest of Development of Assam, Regionalism Should Submerge with Nationalism (অসমৰ উন্নয়ণৰ স্বাৰ্থত আঞ্চলিকতাবাদী সত্বা ৰাষ্ট্ৰীয়তাবাদৰ লগত বিলীন হৈ যোৱাতো উচিত) scheduled to be held on **26th March**, **2023**. The basic objective of this programme is to facilitate the students to develop their skill of Debating. For this purpose, following regulations are formulated —

- 1. All the UG and PG students of Assam will be illegible to participate in the competition
- 2. A team will be constituted with two participants one will be in favour of the motion and the second will be to oppose the motion.
- 3. The participants have to produce their respective institutional identity card.
- 4. Only one team will be allowed from an Institution.
- 5. The Prizes are fixed as follows:
 - a) First Best Debator
 b) Second Best Debator
 c) Third Best Debator
 d) Best Team
 Rs. 10,000/Rs. 5,000/Rs. 3,000/Rs. 4,000/-
- 6. The joining fee of every team is Rs. 500/-.
- 7. The medium of deliberation will be both English and Assamese.
- 8. The intending candidates have to register their names through "online" latest by 20th March, 2023 using a prescribed form. Website: www.taistudiesmoranhat.org.
- 9. The Registration fee may be deposited to the Bank Account Director, Institute of Tai Studies, **State Bank of India, Moran Bazar Branch**; Account No. **11010064574**, IFSC code: **SBIN00015287** with an information to the undersigned. The fee may also be paid in the form of Online, Bank Draft and Cheque payable at Moran. In case of Online transfer, a screenshot of online transaction have to send through Whatsapp no. 9435132505 with applicant's names.
- 10. The leader of Treasury and Opposition Benches will be selected on the basis lottery.
- 11. The leader of treasury bench will be allotted 6 (six) minutes to move the bill and all others members will be given 5 (five) minutes each. Additional 2 minutes of will be given to leader of treasury bench and opposition bench as well to wind up the Debate.
- 12. In respect of result the decision of the judges will be final.
- 13. No TA will be entitled to any participants.
- 14. Competition will be started at 11.00 am. Hence all the participants are required to report at 10.00 am positively.
